LARRY W. WALL AND TINA M. HUNTINGTON PRESENTED 2014 KANSAS ASSOCIATION FOR JUSTICE CONSUMER CHAMPION AWARDS

Topeka, Kan.— The Kansas Association for Justice (KsAJ) announces Larry W. Wall, and Tina M. Huntington, both of Wichita, Kan., were selected by their peers to be presented with the association’s Consumer Champion Award. They were honored with the award for filing a civil rights lawsuit on behalf of Edgar Richard, Jr., a man with mental illness confined in Sedgwick County. The lawsuit achieved substantial improvements in the management, living conditions, and treatment of all prisoners with mental illnesses and disabilities housed in the Sedgwick County Detention Facility.

The KsAJ Consumer Champion Award recognizes noteworthy contributions to the preservation, enhancement or advancement of the legal rights or interests of Kansans beyond an individual case. Each year nominations are received from KsAJ members and the KsAJ Awards Committee selects a slate of recipients. The award is presented in December during the association’s Annual Meeting & CLE Seminar in Kansas City, Mo.

Mr. Wall was born and raised in Wichita. He received his Juris Doctor from Southern Methodist University School of Law. He has previously been awarded KsAJ’s Consumer Champion Award (2002) and the Distinguished Service Award (2012). His practice focuses on representing victims of medical malpractice, victims of serious personal injuries, heirs of wrongful death, and victims of civil rights discrimination.

Ms. Huntington is also a native Kansan. She received her Juris Doctor from Washburn University School of Law. She handles cases involving civil rights violations and helping victims of medical malpractice, serious auto and truck injuries, Vaccine Injury, and Social Security Disability matters.
